PROHIBITIONS; REQUIREMENTS. Sec. 408.[42 U.S.C. 608] In General.—No assistance for families without a minor child.— A State to which a grant is made under section 403 shall not use any part of the grant to provide assistance to a family unless the family includes a minor child who resides with the family (consistent with paragraph (10)) or a pregnant individual.
